Applications must be submitted to the WIN Energy REMC office no later than 4:30 p.m. local time on February 16, 2018. Applications can be downloaded from our website and completed electronically. Recipients will be recognized and awarded certificates at the WIN Energy REMC Annual Meeting April 7, 2018. Scholarship funds will be disbursed to the student upon proof of enrollment.

QUALIFICATIONS:

- The parents/legal guardians of the applicant must be WIN Energy REMC members.
- Applicant must be a 2018 graduating senior and have maintained a cumulative grade point average of a C or higher. A copy of the high school transcript is required.
- Scholarship funds may be applied toward tuition or course fees at any recognized two-year or four-year college or trade school.
- Recipients must be enrolled as a full time student in the fall of 2018. Proof of enrollment must be presented to WIN Energy REMC.
- Full or part-time employees of WIN Energy REMC; or a spouse, son, daughter, stepson, stepdaughter, grandchild, brother, sister, aunt, uncle, niece or nephew of an employee or director of WIN Energy REMC are ineligible to apply.
